Role of the Health Indicators Warehouse (HIW)


 To meet the needs of multiple NCHS clients for indicators of population health, health care, and health determinants

 To serve as the data hub of the HHS Community Health Data Initiative (CHDI)—one of five flagship initiatives in the HHS Open Government Plan

Conceptual Framework for CHDI

Data Sources

- Health Indicators Warehouse (HIW)
 containing health care, health, and
 health determinant indicator data for
 communities, plus data on successful
 interventions by indicator. Will include
 data never previously released, and be
 delivered in a structured, standardized,
 machine-readable, easily accessible way,
 free of charge and intellectual property
 constraint
- Other federal data sets
- State and local governments
- Private sector data suppliers
- Others?



Health Indicators Warehouse Functionality

- Preconstructed national, state, and local level indicators; no individual-level data
- Ability to map, chart, graph, and trend indicators (to the extend data allow)
- Links from indicators to evidence-based interventions
- Web service—peer-to-peer/business application capability
- Inclusion of most indicators from HP2020, County Health Rankings, SUSA, and CHSI
- Supporting metadata to facilitate appropriate use of indicators

Health Indicators Warehouse: To do's

- Build HIW v1.0; populate with indicators (including metadata) and interventions; launch December 2010
- Secure funding to maintain warehouse
- Establish a governance structure to address such issues as:
 - Statistical quality standards for indicators
 - Processes for harmonizing indicators across agency and organization partners
 - Priorities for new indicators, updates and improvements
- Work with CHDI partners to:
 - Provide technical assistance
 - Obtain input for improvements
- Develop mechanisms for user feedback

Proposed HIW Governance Structure Components

- Statistical Standards Group
- Indicator Advisory Group
- NCHS Board of Scientific Counselors

Statistical Standards Group (SSG)

Membership

 A small group of statistical experts from NCHS, other federal agencies

Role

- Establishing statistical & methodological criteria for HIW indicators
- Determining whether new/modified indicators meet criteria
- Monitoring existing indicators

Indicator Advisory Group (IAG)

Membership

 Representatives of federal agencies that provide data and/or funding support for the warehouse

Role

 Recommendations on priorities for addition, modification, or deletion of indicators (based on information from SSG)

Role of Board of Scientific Counselors

- Advising on SSG membership
- Reviewing statistical & methodological criteria developed by SSG; advising on their use
 - Minimum standards vs rating mechanism
- Advising on indicator harmonization strategies
- Serving as a sounding board for new directions proposed by IAG
 - Indicators
 - Warehouse functionality
- Providing feedback from constituents
