Division of Health Interview Statistics News

 2012 National Health Interview Survey (NHIS) public-use microdata files released on June 28, less than 6 months after end of the data collection year.

NHIS 2013 National Health Care Interview Survey

- Creating a web panel from the 2012 NHIS
- Sample = 12,000 (May 2013-Feb 2014)
- Assigned to email, internet, phone
- Content
 - Health status, health care access & use, health insurance, health behaviors, food security
 - Starting Oct 1 health insurance marketplace

NHIS 2013 National Health Care Interview Survey

- Uptake of web-based survey methods
 - Provision of re-contact information in the follow-back survey
 - Email churn
- Data quality considerations
 - Differences in responses by web vs. phone
 - Assessment of selection and response biases
 - Impact of mode crossover
- Paradata indicators
 - Item and survey completion time
 - Response directionality within the web instrument

Using the ACS to Expand the NHIS Sample

- 2014 NHIS questionnaire administered to a sample of households containing Native Hawaiian Pacific Islander (NHPI) persons identified in the 2012 American Community Survey (ACS).
 - January July 2014
 - Sample 4,000 persons
- Meets goal of improving the collection and reporting of data on NHPI populations.

Planning for the NHIS Redesign: Sample

- NHIS, ORM and Census collaborating on redesign
- 2016 implementation
 - Use of commercial address files as a source of household addresses -- replaces expensive listing
 - More flexibility to increase or decrease the sample size (new PSUs) or repurpose the sample (state or minority subgroups)

Planning for the NHIS Redesign: Content & Mode

- Retention of in-person interviewing for the basic survey, with the ability to add a telephone component to augment sample size (one address-based sample for both modes).
 - Collection of some data via the Internet to supplement the sample.
- Redesign of the questionnaire (2017), including development of shorter questionnaire to use with a telephone component.

The NHANES National Youth Fitness Survey

The NHANES National Youth Fitness Survey (NNYFS) was conducted in 2012 to collect data on physica activity and fitness levels in order to provide an evaluation of the health and fitness of children in the U.S. ages 3 to 15. The NNYFS collected data on physical activity and fitness levels of our youth through interviews and fitness tests.



In October 2008, the federal government issued its first-ever Physical Activity Guidelines for Americans to provide science-based guidance on the types and amounts of physical activity that provide substantial health benefits for Americans. Guidelines for children and teens ask for 60 minutes or more of aerobic, muscle-strengthening, or physical activity daily.

While the number of children in the U.S. who meet the Physical Activity Guidelines is unknown, the percentage of children who are physically active in the U.S. is declining. The inclusion of fitness tests. in the NNYFS for ages 3-15, provides additional information with which to evaluate the health of this age group.

The survey was conducted in 2012 by the Division of Health and Nutrition Examination Surveys, National Center for Health Statistics, part of the Centers for Disease Control and Prevention.

- 2012 National Ambulatory Medical Care Survey (NAMCS) data coming this Fall.
 - State-specific estimates of care provided in physician offices and community health centers for 32 states.
- Computerization of NAMCS data has made it possible to release 2012 data before 2011.
- NAMCS National Survey of Electronic Health Record Use will release the 2013 EHR data by early Dec.

- National Study of Long-Term Care Providers first report release coming Dec 2013.
- 2012 survey data (for adult day and for assisted living/residential care communities) available through the RDC near late Sept.



- 2013 NAMCS is collecting data to describe the composition of the practice team and the roles and responsibilities of members.
- Exploring methods to develop a sample frame for nurse practitioners and another for physician assistants.



 Pilot studies aimed at extracting data from EHRs for NAMCS, National Hospital Ambulatory Medical Care Survey (NHAMCS) and National Hospital Care Survey (NHCS).



Division of Vital Statistics

- Completed funding of states for establishment of electronic birth registration systems.
- Special projects:
 - Funded 2 states to evaluate the quality of birth certificate information compared to medical records.
 - Funded 6 states to improve timeliness of death certificate information and physician participation with their electronic death registration systems.
 - Funded 1 state to accelerate development and implementation of an electronic death registration system, including getting physician participation.


