NOTE: This data dictionary is for use when requesting variables as part of a research proposal submitted to the NCHS Research Data Center. While these items may be requested, obtaining them is based on approval of the submitted proposal. Certain items, including but not limited to, those pertaining to specific geography, or to external data sources such as NPI number, are not given directly to researchers, but can be used by Research Data Center staff for merging files and creating broader categories. The data dictionary pertains to both traditional NAMCS physicians and providers sampled within Community Health Centers (CHCs), but at present, only NAMCS data are available. MU/EHR is Meaningful Use/Electronic Health Records and refers to those physicians who agreed to participate through submission of electronic medical records. MU/EHR physicians were only asked a subset of the questions included in the Physician Induction Interview, as shown below.
