From Bangkok to Amman:

12th Annual Meeting in Bangkok, Thailand: Oct, 2012

- The meeting was attended by 40 persons:
 - 20 representing national statistical authorities from 18 countries
 - 7 from universities, national institutes of public health, other national research bodies or government ministries
 - 3 from the National Center for Health Statistics (WG Secretariat)
 - 3 from Disabled Person's Organizations
 - 7 from international organizations (UNESCAP, WHO, EU Agency for Fundamental Rights)

Main Objectives: 12th meeting in Bangkok

- Present additional work on extended set (functioning):
 - Results from further analyses of data from the US National Health Interview Survey
- Present additional work on the development of questions on child functioning and disability
 - Presentation of proposed question set

Major accomplishments in Bangkok and beyond

- Development of a Module on Child Functioning and Disability (with UNICEF)
