The Occupational Safety and Health Act of 1970 resulted in the establishment of three major organizations at the Federal level--the National Institute for Occupational Safety and Health (NIOSH) in the Department of Health and Human Services; the Occupational Safety and Health Administration (OSHA) in the Department of Labor; and the Occupational Safety and Health Review Commission. Passage of the Act also resulted in renewed efforts at the State and local levels toward eliminating on-the-job hazards.

This Directory lists the names, titles, addresses, and telephone numbers of key personnel in NIOSH, OSHA, the Review Commission, as well as the Mine Safety and Health Administration (MSHA). Also listed are governor-designated and other State agencies as well as local agencies responsible for worker safety and health.
